There are a few ways to pay for your child's care including Government funding.

Eligible working families with a valid code from

www.beststartinlife.gov.uk

**to receive 30 hours (term time only), or
22.36 hours stretched (51 weeks) over the year.**

A full day counts as 10 hours and a session as 5 hours.

**We follow relevant Sunderland & Newcastle City
Council's school term dates.**

Funding support starts the term after your child turns 9 months

- 1 January and 31 March they are eligible for Summer Term.
- 1 April and 31 August they are eligible for Autumn term
- 1 September and 31 December they are eligible for Spring Term

9 MONTHS OLD OFFER

To access FREE 15 hours from 1 September 2026 your child must have been born before 31 December 2025. If their birthday is between 1 January and 31 March 2025, they will be eligible for Government support from Spring term 2027, starting 4 January.

If you are on maternity or paternity leave, or if you are unable to work due to a disability or caring responsibilities you may still be eligible. Support also available for parents under the age of 21.

We DO NOT CHARGE for Christmas closure week.

We charge £6 per day for meals, £4 per morning session and £2 per afternoon session.

Notes to go with price list

- Children under 2 years old must attend for a minimum of 4 sessions or 2 days a week. Children 2 years and over for a minimum of 2 sessions or 1 day a week.
- Parents/carers to provide breast milk/formula milk
- Parent/carers are to provide nappies, baby wipes, creams, suntan lotion, spare clothes, hats, outdoor waterproof suits and wellies.
- Six weeks' notice, in writing, is required when you alter your child's attendance or when a child leaves the nursery or six weeks' fees are payable in lieu of notice. 4 weeks' notice for changing funding.
- Late collection of a child after 1.00pm or 6.00pm will incur a £10 fee for first 10 minutes. Over 10 minutes late a full session fee will apply. This applies to ALL children.
- Early Bird from 7.30am is £12 and must be pre-booked
- Planned attendance is charged and should your child be absent for whatever reason, a refund will not be applied. This includes illnesses/medication/injections etc. (please see Communicable Diseases Chart)
- Registration fee of £40 payable when your place is confirmed.
- Open 51 weeks a year - closed between Christmas and New Year and on Statutory Bank Holidays (no charge).
- Meals cost £6 per day, £4 per morning session and £2 for afternoon sessions (families receiving early learning for 2 year old funding are exempt)
- We support our emergency services**
10% off for NHS & Blue Light Card holders.
- Family friendly we offer **10% off sibling fees.** (discount applied to lowest fee).
- There are **no multiple discounts.**
Only the single biggest saving will be applied to your invoice.

In the case of full week, this will be 15% off invoice after FREE entitlement deducted

Fee Payment

- Invoices are itemised and are due in advance, for example, an invoice for days in September will be issued mid-August and fees due on 1st September.
- If you are paying via Tax Free Childcare please make an extra 3-5 day allowance for processing time.
- All late payments will incur a 15% surcharge on amount outstanding each month. eg £200 outstanding will have a fee of £30 added.
- We offer a wide range of payment options via Debit/Credit Card, Electronic transfer, Tax Free Childcare or cash.
